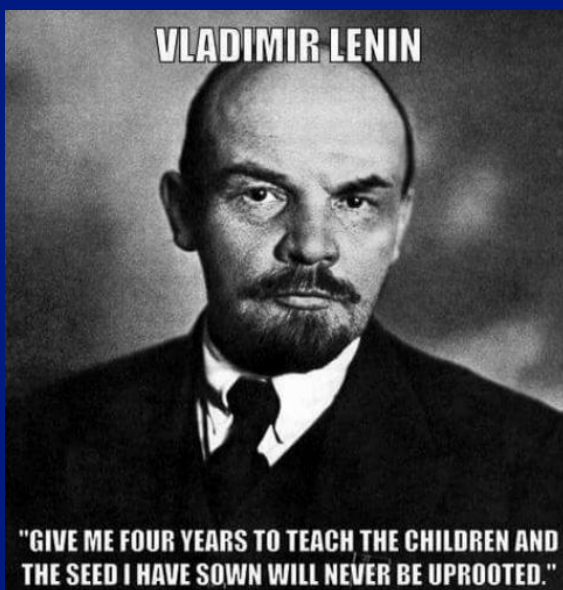

We are pleased to announce to you a new Champions of Liberty program entitled "Conference of Leadership." It will launch Sunday, 18 April 2021, from 1700 hrs – 1800 hrs central time.

"Conference of Leadership" is a monthly Sunday evening one-hour Zoom call for COL members only. The format consists of a presentation, followed by Q&A, with national experts on hot button topics regarding the "Rescue of America." Each program or series of programs will incorporate an action plan we must undertake to turn the rising tide of Postmodernism before it eradicates our Constitutional Republic, along with the rest of Western Civilization and culture.



The inaugural Conference of Leadership program will dive deeply into Critical Race Theory. [Carol Swain](#), a retired professor of political science and law at Vanderbilt University, and a staunch activist against critical race theory is scheduled to discuss Critical Race Theory in our educational system, government, the corporate world, and its effect on the American culture.
